ORDER

WHEREAS, the recognition was granted to the institution namely **DBHPS B.ED. TRAINING COLLEGE, AMBADIMALA, THIRUVANKULAM-682305, ERNAKULAM DISTRICT, KERALA** vide SRC (NCTE) order No.F.KL/SRO/NCTE/DBHPS/2004-2005/1463 dt. **23.03.2005** for conducting B.Ed. course of one-year duration with an annual intake of 100 students from the academic session 2004-2005, which includes the existing intake of 60 and an additional intake of 40 students.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted an affidavit dated **15.01.2015** for its willingness for adherence of provisions of new Regulations.

AND WHEREAS, a Revised Provisional Recognition Order was issued to the institution on **15.05.2015** for conducting B.Ed. course of two years duration with an annual intake of **100 students (two basic units of 50 students each)** from the academic session **2015-2016**.

AND WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the SRC in its 369th meeting held on 28.01.2019 and the committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance on the following points:-

1. A copy of staff profile of qualified teaching staff appointed by institution for session 2015-2016, 2016-2017, 2017-2018 duly approved by affiliating body.
2. Building Completion Certificate as per Government format issued by RES/Govt. Engineer is not submitted.
3. FDRs of Rs.5 lakhs as Endowment fund, and Rs.7 lakhs as Reserve Fund per course in joint operation with Regional Director, SRC (NCTE) as per NCTE Regulation, 2014 is not submitted.
4. Originally notarized CLU (Certificate of Land Use), Non-Encumbrance Certificate, Approved building plan issued by engineer of Rural Engineering Service or PWD Engineer.

AND WHEREAS, Show Cause Notice issued to the institution on **17.07.2019** on the aforesaid grounds. In response, the institution submitted its compliance on **19.08.2019 & 28.01.2020**.

AND WHEREAS, the SRC in its 384th meeting held during February 12-13, 2020 considered the matter and decided as under: -

"The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

*Further, on the perusal of the reply, documents and records submitted by the Institution, Committee also decided that the continuation order be issued to the Institution **DBHPS B.Ed. Training College, Thiruvankulam-682305, Ernakulam District, Kerala for B.Ed programme for 2 basic units of 50 students each**".*

NOW THEREFORE, this order is issued permitting the institution **i.e. DBHPS B.ED. TRAINING COLLEGE, AMBADIMALA, THIRUVANKULAM-682305, ERNAKULAM DISTRICT, KERALA RUN BY DAKSHINA BHARAT HINDI PRACHAR SABHA, CHITTOOR ROAD, ERNAKULAM, KOCHI-682016** for continuation of recognition for B.Ed. course of two years duration with an annual intake of **100 students (two basic units)** subject to fulfillment of the following conditions:-

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc as applicable.

The institution shall submit to the Regional Committee as Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely: -

- a. Sanctioned programme(s) along with annual intake in the institution;
- b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c. Name of faculty members who left or joined during the last, quarter;
- d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- e. Fee charged from students;
- f. Available infrastructural facilities;
- g. Facilities added during the last quarter;
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;

- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information, if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.

The institution shall make available the list of students admitted on its official website.

The institution shall fill the information on GIS Portal on the NCTE Website. If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993. Also order that a copy of this Order be published in the official Gazette.
